Matrox safety information



To ensure safe and reliable operation of your Matrox product, to avoid personal injury, and to prevent damage to your computer or Matrox hardware, read the following guidelines.

Installation and operation

- Read and retain all instructions. Only use your Matrox product according to the instructions, operating ranges, and guidelines provided in the Matrox user guide and other related Matrox documentation. Failure to follow these instructions could result in damage to your product or injury to the user or installer.
- Don't expose your Matrox product to rain, water, condensation, or moisture.
- Your Matrox product (card or unit) can become hot while operating. Always turn off your computer, unplug it, then wait for it to cool before touching any of the internal parts of your computer or installing your Matrox card. Allow hot surfaces to cool before touching your Matrox unit. 
- Static electricity can severely damage electronic parts. Before touching any electronic parts, drain static electricity from your body (for example, by touching the metal frame of your computer).
- When handling a card, carefully hold it by its edges and avoid touching its circuitry.
- Don't stack devices or place devices so close together that they're subject to recirculated or preheated air.
- Don't operate your system or Matrox product near a heat source or restrict airflow to your system, and make sure the ambient temperature doesn't exceed the maximum recommended temperatures. Don't block ventilation holes on your unit or system.

If a power supply (internal or external) was included with your product

- Don't place the external power supply directly on top of the device.
- Only use power supplies originally supplied with the product or use a replacement that's approved by Matrox. Don't use the power supply if it appears to be defective or has a damaged chassis.

- Don't defeat the safety purpose of the polarized or grounding-type plug. A polarized plug has two blades with one wider than the other. A grounding-type plug has two blades and a third grounding prong. The wide blade or the third prong are provided for your safety. If the provided plug doesn't fit into your outlet, consult an electrician to replace the obsolete outlet.
- Make sure that nothing rests on the power cables and that the cables aren't located where they can be stepped on, pinched, or tripped over.
- Don't use damaged power cables.
- Unplug your system or device during lightning storms or if unused for long periods of time.

If your product includes laser-based technology

- The device contains a Class 1 laser product for use only under the recommended operating conditions and guidelines. For more information, see your Matrox user guide.
- Invisible laser radiation may be emitted from disconnected fibers or connectors. Don't stare into beams or view directly with optical instruments.
- Only use optical transceivers originally supplied with the product or use a replacement that's approved by Matrox.

If your product includes a battery

- The battery is non replaceable.

Repair

Overview

Thank you for purchasing a Matrox Extio product. This product is designed for environments requiring data security, low heat emissions, and noise reduction. Leveraging PCI Express® bus extension technology, Extio separates input and output devices from the computer to provide a working environment similar to when the computer is at the user's desk.

Hardware supplied*

- Extio F2208 – Matrox Extio unit, 2 DisplayPort™ to DVI-D adapters, 1 power supply.
- Extio F2408 – Matrox Extio unit, 4 DisplayPort™ to DVI-D adapters, 1 power supply.
- Extio F2408E Expander – Matrox Expander unit, 4 DisplayPort™ to DVI-D adapters, 1 power supply, 5 meters of LC-LC optical cable.

Hardware required (sold separately)

- PCIe® interface card ([see shopmatrox.com](https://shopmatrox.com))
- LC-LC optical cable - multimode (62.5/125 µm (OM1), 50/125 µm (OM2, OM3, or OM4)) or LC-LC optical cable - single-mode (9/125 µm (OS1 or OS2))

Installing your interface card

This section describes how to install your Matrox interface card. For information specific to your computer, like how to remove its cover, see your system manual.

Before you begin

To avoid personal injury and to prevent damage to your computer or Matrox hardware, read the following guidelines before installing your Matrox graphics hardware.



Note: When changing your hardware configuration by adding or removing an Extio unit or by adding, removing, or moving an interface card from one slot to another, you need to uninstall and reinstall your Matrox software.

Preventing damage to your interface card

- Always turn off your computer, unplug it, then wait for it to cool before touching any of the internal parts of your computer or installing your Matrox product.
- While your computer is turned off but still plugged in, some electrical current is supplied to the motherboard. This current may prevent newly installed hardware from working properly.
- Static electricity can severely damage electronic parts. Before touching any electronic parts, drain static electricity from your body (for example, by touching the metal frame of your computer).
- When handling a card, carefully hold it by its edges and avoid touching its circuitry.
- Always try to insert or remove your card as straight as possible.

Using multiple interface cards and units

You can use multiple interface cards and units to add more monitors to your setup. When using multiple cards and units, the following guidelines apply:

- Any combination of Extio units can support up to eight (8) monitors at a time.
- An Extio F2408E Expander unit can be connected only to an Extio F2408 unit.
- An Extio F2208 unit can be connected only to the second interface card.

Step-by-step installation

1 Open your computer and remove your existing graphics card

If a graphics card *isn't* already installed in your computer, skip to [step 2](#).

If a graphics card *is* already installed in your computer:

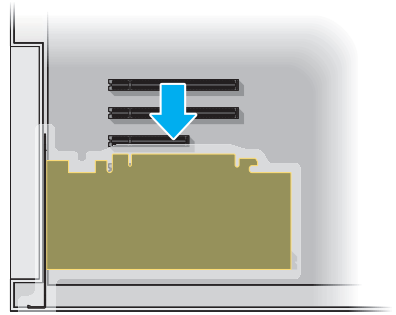
- a Using **Apps & features** (Windows® 10) or **Programs and Features** (Windows® 8.1/7) in the Windows **Control Panel**, remove any currently installed display drivers. Restart your computer for the changes to take effect.

After your computer restarts, you're prompted to install drivers for the new graphics hardware detected. Click **Cancel**.

- b Turn off your computer and all peripherals such as your monitor or printer.
- c Open the computer and remove your existing graphics card (if any).

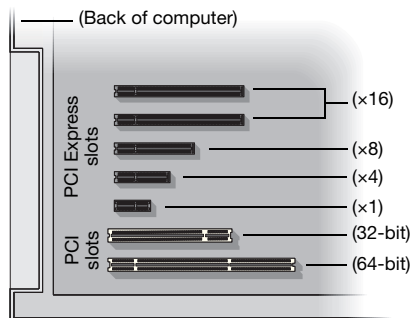


Note: If graphics hardware is built into the motherboard of your computer, make sure it's disabled. For more information, see your system manual.



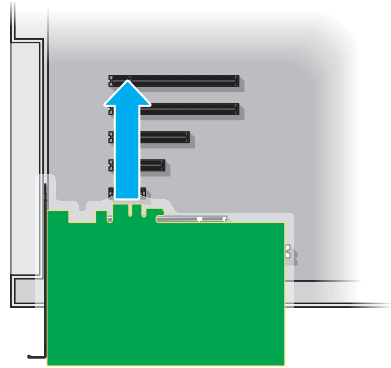
2 Choose an expansion slot

Most computers have different types of expansion slots. Your interface card is a PCIe ×1 card. It's compatible with all PCIe slots. To ensure maximum system compatibility, we recommend you use a PCIe ×16 slot. Your system manual should identify the location of each type of expansion slot in your computer.



3 Insert your Matrox card

- a** Position your Matrox card over the expansion slot you've chosen.
- b** Push the card in firmly and evenly until it's fully seated in the slot.
- c** Secure the bracket of your Matrox card to the computer frame.



Your Matrox card is now installed. *Before restarting your computer*, connect your interface card and your monitors to your Extio unit (see “[Connecting your Extio unit](#)”, page 11). Connect your Expander unit (if present) to your Extio unit (see “[Connecting your Expander unit](#)”, page 18). *After connecting*, you can restart your computer and install your Matrox software (see “[Installing your Matrox software](#)”, page 20).

Connecting your Extio unit

This section describes how to connect your Matrox Extio unit, monitors, and other peripherals.

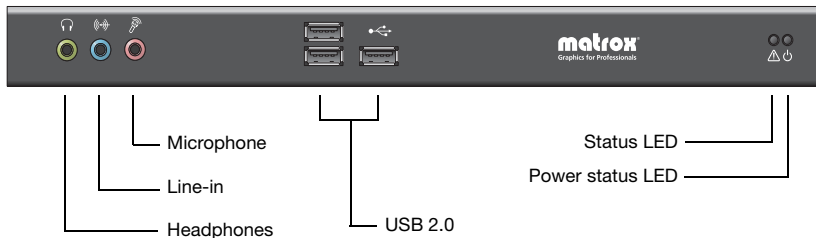
Before you begin

To avoid possible problems that could damage your monitors or prevent you from using your Matrox product, read the following guidelines before connecting your Matrox graphics hardware.

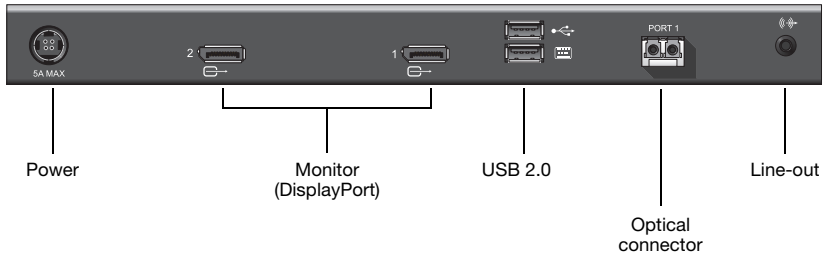
- Whenever you change your connection setup, make sure you're using the correct connectors and that all connectors are properly fastened.
- Don't change monitor connections while your computer is turned on. While your computer is turned on, it may be using monitor settings that are specific to the current monitor connections. *Some* devices may be permanently damaged if incorrect settings are used.
- Whenever you restart your computer, make sure your monitors are already turned on. Otherwise, the software may not be able to properly detect your monitors.
- To prevent your unit from overheating, make sure your unit is located in a well ventilated area and nothing is blocking its ventilation holes. For more information, see [“Appendix A – Providing adequate airflow”](#), page 39.

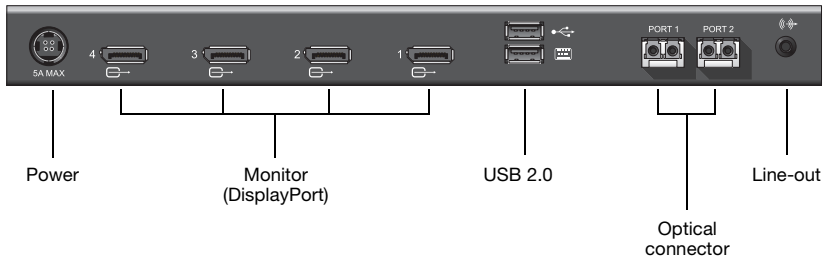
Front – Extio F2208 and F2408



Back – Extio F2208



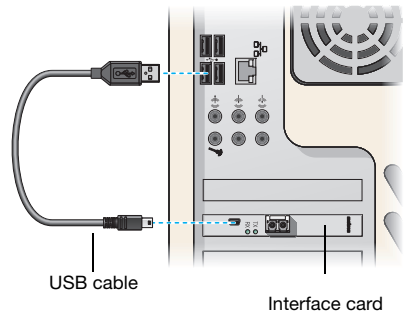

Step-by-step connection setup

1 Connect your USB cable

Connect one end of your USB cable included with your product to the USB connector on your interface card. Connect the other end of your cable to a USB connector on the motherboard of your system. Make sure your connectors are properly connected.



Note: To use a keyboard with your unit before your operating system starts, the USB cable must be connected from your interface card to your computer. Also, to use the audio hardware of your unit after your operating system has started, this cable must be connected.

2 Connect your unit to your interface card

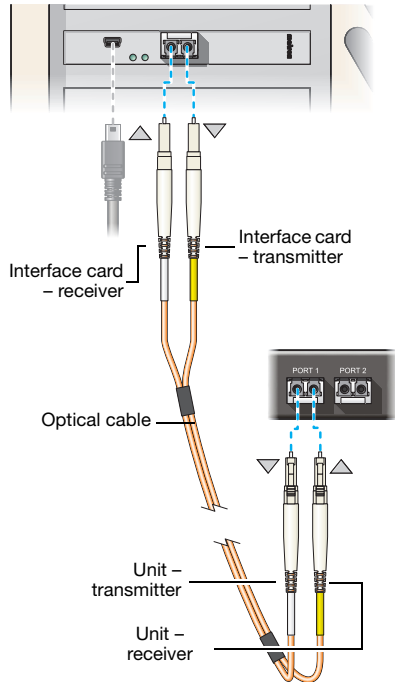
To connect your Extio unit to your interface card, you need an LC-LC optical cable (sold separately).

Connect one end of your optical cable to the optical connector of your interface card. Connect the other end of your optical cable to the optical connector labeled **Port 1** on your unit. Make sure your connectors are properly connected.

When connecting your fiber optic cable, make sure the connector on one end of your fiber optic cable attached to the transmitter side of a transceiver is connected on the other end of the cable to the receiver side of the other transceiver.



WARNING: Disconnecting your optical cables while your computer is turned on will cause your operating system, your program, and your unit to stop responding.



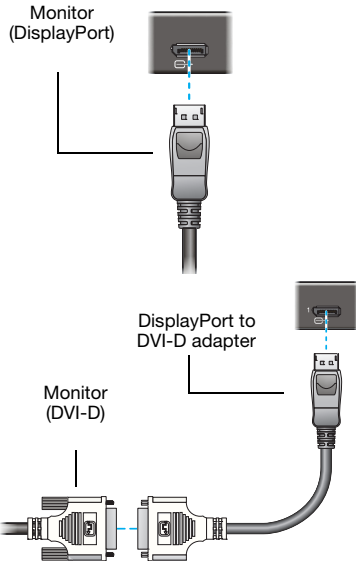
Note: Color coding and labeling on the fiber optic cable and on the transceivers are for clarity. Labeling on your cable and transceivers may differ.

3 Connect your monitors

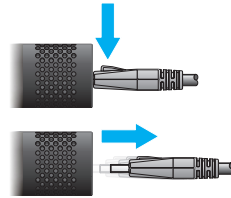
Connect your monitors to the monitor connectors (starting with connector 1) at the back of your Extio unit.

If your monitor has a DisplayPort connector, connect your monitor directly to a DisplayPort connector at the back of your unit.

If your monitor has a DVI-D connector, use a DisplayPort to DVI-D adapter to connect your monitor cable to the DisplayPort connector at the back of your unit.



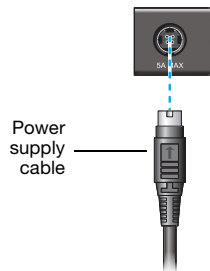
WARNING: To avoid damaging the DisplayPort connector on your DisplayPort monitor cable or on your Matrox product, carefully remove the DisplayPort cable by pressing the latch on the top of the DisplayPort connector while removing the connector.



4 Connect your power supply

Attach one end of the power supply cable provided with your Matrox product to the power connector on your Matrox product.

Plug the power supply cord into an electrical outlet.

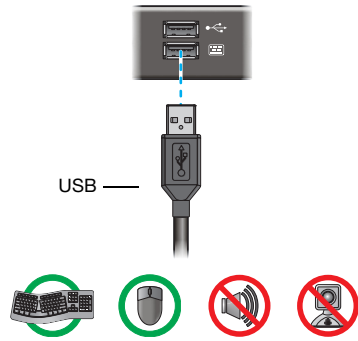


5 Connect your input devices (optional)

To use a USB device (such as a keyboard or mouse), connect it to a USB connector on your unit. There are two USB connectors at the back of the unit and three at the front.

Note: Isochronous USB devices (for example, USB audio and video devices such as a microphone or camera) aren't supported with an Extio unit.

Note: To use a keyboard with your unit before your operating system starts, connect the USB connector of your interface card to your computer (see “Connect your USB cable”, page 12), and connect your keyboard to the USB connector labeled with a keyboard icon (🖱️) at the back of your unit.



6 Connect your audio devices (optional)

Your unit has two input connectors (**Line in** (🔊) and **Microphone** (🎤)) and two output audio connectors (**Headphones** (🎧) and **Line out** (🔊)). All audio connectors support stereo jack connectors.

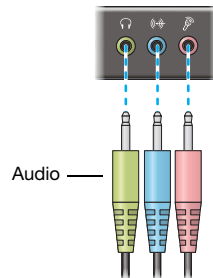
To connect an audio device to your unit:

- Plug one end of your audio cable into the audio connector on your unit.
- Plug the other end of the cable in your audio device. For information on the type of connector supported by your audio device, see its documentation.

Note: To use the audio hardware on your unit, your interface card needs to be connected to your computer with a USB cable (see “Connect your USB cable”, page 12).

If you're using multiple interface cards in your system, make sure you enable the audio driver for the unit to which your audio hardware is connected.

Note: Audio output is enabled on the **Line out** (🔊) connector even while a device is connected to the **Headphones** (🎧) connector.



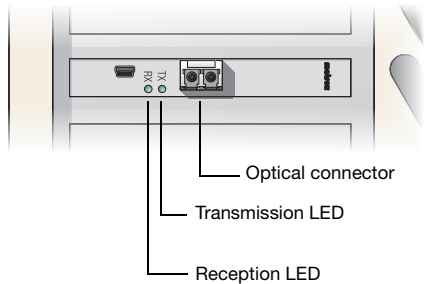
Validating your connection setup

After connecting your unit, we recommend you validate your connection setup before you continue.

1 Check the optical connection on your interface card(s)

After starting your computer and your Extio unit, make sure both the transmission (**TX**) and reception (**RX**) LEDs on the bracket of your interface card are green. If the reception LEDs is red, switch the cables in the optical connector of your Matrox product.

If the light doesn't change to green, make sure your Extio unit is powered and that your optical cable is properly connected.



2 Check your monitor connections

When your computer starts, the system BIOS prompt should appear on your primary display (on the monitor attached to connector 1 of your Extio unit).

If the system BIOS prompt doesn't appear, your computer may have built-in graphics hardware. Check your system manual for instructions on how to disable your computer's built-in graphics hardware.

3 Check your keyboard connection

When the Extio BIOS prompt appears on your display, press [F7] to enter the Extio Setup Utility. This ensures that the keyboard is properly detected and functional before Windows starts. In the setup utility, select **Options** → **Cancel and exit**.



Note: On certain systems, instead of the Extio BIOS prompt, an umbrella menu may appear asking you to press [Space] or another key to access additional ROM menus. If you're able to enter the additional ROM menu by following the instructions provided in the umbrella menu, your keyboard connection is valid.

If your keyboard isn't available before Windows starts, your keyboard may be connected to the wrong USB connector. For more information, see [“Connect your input devices \(optional\)”](#), page 15.

If your keyboard is properly connected, it may not be supported by your Extio unit. Only basic USB keyboards are supported by your Extio unit before Windows starts (for example, USB keyboards that have no USB hubs or media controls).

4 Check your input devices in Windows

Make sure any USB Human Interface Devices (HID), such as your mouse and keyboard, are working properly in Windows.

If any of your HID devices aren't working properly, Windows may not have detected your HID device. For more information, see [“USB keyboard or mouse doesn't work”](#), page 28.

Your Matrox product is now installed. If you want to connect an Expander unit, see [“Connecting your Expander unit”](#), page 18. Otherwise, restart your computer and install your Matrox software (see [“Installing your Matrox software”](#), page 20).

Connecting your Expander unit

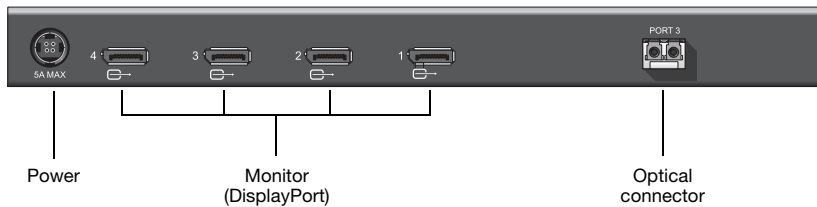
Note: You can connect an Extio F2408E Expander unit only to an Extio F2408 unit.

This section describes how to connect an Expander unit (sold separately) to your Extio unit. Connecting an Expander unit to your Extio unit enables you to support four additional monitors.

Note: When changing your hardware configuration by adding or removing an Expander unit, you need to uninstall and reinstall your Matrox software.

Back – Extio F2408E Expander

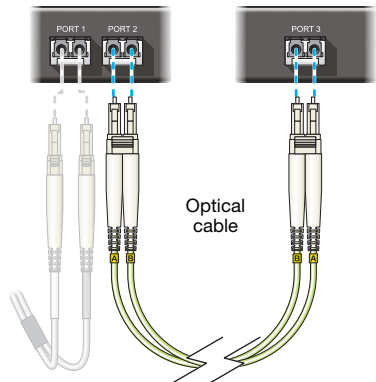


Step-by-step connection setup

1 Connect your Expander unit to your Extio unit

Connect one end of the optical cable provided with your Expander unit to the optical connector labeled **Port 2** on your Extio unit.

Connect the other end of your cable to the optical connector labeled **Port 3** on your Expander unit. Make sure your connectors are properly connected.



Note: Labeling on the fiber optic cable is for clarity. Actual labeling may differ.



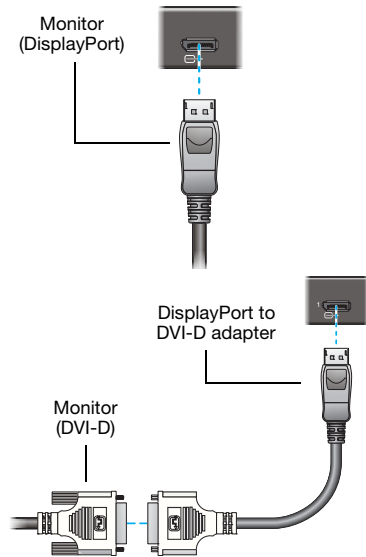
WARNING: Disconnecting your optical cables while your computer is turned on will cause your operating system, your program, and your unit to stop responding.

2 Connect your monitors

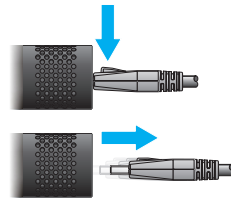
Connect your monitors to the monitor connectors (starting with connector 1) at the back of your Expander unit.

If your monitor has a DisplayPort connector, connect your monitor directly to a DisplayPort connector at the back of your unit.

If your monitor has a DVI-D connector, use a DisplayPort to DVI-D adapter to connect your monitor cable to the DisplayPort connector at the back of your unit.



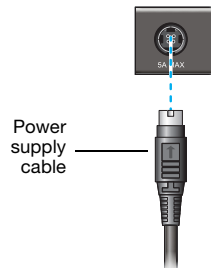

3 Connect the power supply for your Expander unit

Attach one end of the power supply cable provided with your Matrox product to the power connector on your Matrox product.

Plug the power supply cord into an electrical outlet.



Your Matrox Expander unit is now connected. Restart your computer and install your Matrox software (see “[Installing your Matrox software](#)”, page 20).

Installing your Matrox software

This section describes how to install Matrox software for *Windows® 10*, *Windows® Server® 2016*, *Windows® 8.1*, *Windows® Server® 2012 R2*, *Windows® 7*, and *Windows® Server® 2008 R2*. The installation of the display driver is the same for the 32-bit and 64-bit versions.

Before you begin

- You may need administrator rights to install or uninstall certain software. For more information, see Windows documentation or contact your system administrator.
- When updating your display driver, we recommend you first uninstall your previous display driver.
- When changing your hardware configuration by adding or removing an Extio or Expander unit or by adding, removing, or moving an interface card from one slot to another, you need to uninstall and reinstall your Matrox software.

Obtaining a display driver

- If your Matrox product was provided by an OEM, a distributor, or a system integrator, contact them for the latest display driver. Such a display driver is more likely to be tested with your computer model.
- Matrox makes the latest display drivers available on the Matrox Technical Support Web site (www.matrox.com/graphics/en/support/drivers).

Hardware detection

- **Windows 10/8.1** – Windows detects new hardware when you restart and installs a Microsoft Basic Display Driver.
- **Windows 7** – Windows detects new hardware when you restart and installs a standard VGA driver.


Installing your display driver

To install the display driver for your Extio product, run the executable file for your display driver package. The display driver package decompresses itself into an installation folder. Follow the on-screen instructions.



Note: After the installation, keep the installation folder in your system to ensure that all files (including the additional driver files for your product) are still available for installation.

Validating your driver installation

After your display driver is installed, the status LED () on your unit should turn from orange to green.

If audio doesn't work on your Extio unit, see [“Sound”](#), page 32 for more information.

Matrox PowerDesk software



Your Matrox display driver includes Matrox PowerDesk software. This software helps you get the most out of your Matrox product. Use Matrox PowerDesk software to change certain display settings or access Matrox features.

Accessing PowerDesk


Windows 10/8.1/7 – To access Matrox PowerDesk:

- Click **Matrox PowerDesk** in the Matrox Graphics folder of your **Start** menu or **Start** screen.
- Right-click your Windows desktop and select **Launch Matrox PowerDesk**.

Accessing Matrox PowerDesk help

For information on Matrox PowerDesk software features and options, see the help file included with your PowerDesk software.

While using Matrox PowerDesk software, you can access the help file in several ways:

Description of LEDs

The LEDs on your Matrox interface card, Extio unit, and Expander unit (if present) provide status information on your connection setup. The following describes the different LEDs:

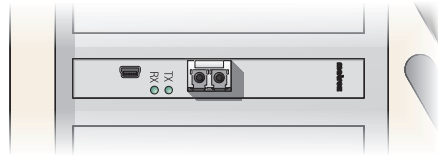

Locating the LEDs

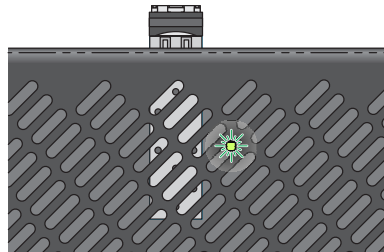
Interface card

On your interface card, the TX (transmitter) and RX (receiver) LEDs are located next to the optical connector on the card bracket.



Extio unit

On your Extio unit, each optical connector has one LED. This LED is located on the side of the optical connector and is visible through the ventilation holes at the top of your unit. The power and status LEDs are visible at the front of the unit.



Troubleshooting

What to do if you have a problem

If you experience problems with your Matrox product:

- Make sure your Matrox card is properly installed, you're using the correct connectors, and that all connectors are properly fastened. For more information, see [“Installing your interface card”](#), page 8 and [“Connecting your Extio unit”](#), page 11.
- Review the documentation provided with your Matrox product, including the information in this section, to see if your problem is already addressed.

Troubleshooting checklist

Here are some steps to take to troubleshoot the more common issues encountered with your Matrox product.

Before installing and connecting your Extio product

- ❑ Make sure your system meets the requirements to support your Extio product. For more information, see [“Specifications”](#), page 35.
- ❑ Make sure your optical cables are supported for the distance between your unit and your system. For more information, see [“Maximum distances”](#), page 35.



Note: Extio is validated for point-to-point connections. For applications requiring non-point-to-point connections, including optical couplers and switches, contact your Matrox representative.

- ❑ Make sure all previously installed display and audio drivers are removed.
- ❑ Make sure your built-in audio device is disabled. For more information, see [page 34](#).
- ❑ Make sure any built-in audio or graphics hardware is disabled in your system BIOS. For more information on how to access your system BIOS, see your system manual.

After installing and connecting your Extio product

If your computer doesn't display information or boot after your interface card is installed:

- ❑ Make sure the LED on your interface card is green. This LED is on the front of the interface card next to the optical connector. If the LED is red, try re-inserting the card or try using a different PCIe slot.
- ❑ Make sure your optical cables are properly connected on both the interface card and Extio unit. For more information, see “Description of LEDs”, page 23.
- ❑ Make sure a monitor is connected directly to the monitor connector labeled **1** at the back of your Extio unit. If a monitor is properly connected, try a different connector type on your monitor (DVI-D).
- ❑ If your computer only displays information after the Windows startup screen, check your system BIOS settings to make sure your Extio unit is set as the primary graphics hardware.

Configuring your Extio product

- ❑ Make sure the latest Matrox display driver package is installed. Matrox makes display drivers available on the Matrox Technical Support Web site (www.matrox.com/graphics/support/drivers.)



Note: You may need administrator rights to install certain software. For more information, see Windows documentation or contact your system administrator.

- ❑ Make sure your multi-display setup has been properly configured in Matrox PowerDesk software. For more information, see Matrox PowerDesk help.

Common problems and solutions

This section addresses common problems that could prevent you from using your computer or graphics hardware.

Problem Wrong color balance, screen image off-center, or no picture at all

Cause Your monitor video controls may be improperly set.

Solution Adjust your monitor controls (brightness, contrast, and so on). For more information, see your monitor manual.

Cause If your monitor supports multiple input sources (analog/digital), it may be configured to use the wrong source.

Solution Make sure your monitor is using the correct input source. For more information on selecting the input source for your monitor, see your monitor documentation.

Solution Change your connection setup to use a different input source. For more information, see “Connecting your Extio unit”, page 11.

Cause Your computer may have re-enabled your built-in graphics hardware.

Solution **Windows 10/8.1/7** – To disable your built-in graphics hardware and re-enable your interface card:

- 1** Connect a monitor to the graphics connector on your computer.
- 2** Disable your built-in graphics hardware.
 - a** Open the Windows **Device Manager**.
 - b** Double-click the **Display adapters** list item to expand it, then double-click the name of your built-in graphics hardware.
 - c** Click **Driver** → **Disable** → **Yes**.
 - d** Click **OK**, then close the Device Manager dialog box.
- 3** Shut down and unplug your computer. Disconnect all other peripherals from your computer for at least 1 minute, then restart your computer.

Problem **After the startup screen, or after display settings are changed, the screen image is garbled or unusable**
(blank screen, rolling or overlapping screen images)

Cause **Analog monitors only** – The Matrox display driver may be trying to use settings your monitor doesn’t support. This can happen if the display resolution was changed to one your monitor doesn’t support or if the monitor connected to your computer was changed without changing the display or monitor settings in the software.



WARNING: If incorrect software monitor settings are applied, *some* monitors can be permanently damaged. For more information, see your monitor manual.

Solution Make sure your monitor supports the display mode currently in use. After installing your Matrox product, your system uses either the preferred display mode for your monitor or a display mode of 800 × 600 at 60 Hz.

Solution If none of your displays are available, reinstall your Matrox display drivers. For more information on reinstalling your display driver, see the following solution.

Cause Files on your system may have been deleted or corrupted.

Solution **Windows 10/8.1/7** – Uninstall, then reinstall Matrox software:



Note: Before removing software, make sure you have all the necessary files to reinstall software that may still be needed. Also, make sure the display driver you reinstall supports *all* Matrox products in your computer.



Note: You may need administrator rights to uninstall certain software. For more information, see Windows documentation.

- 1 If your primary display is unusable, restart your computer in VGA mode:
 - a From the **Start** menu or the **Start** screen, restart your computer.
 - b *Before* Windows starts, press [F8] for the Windows startup menu to appear. (If [F8] doesn't work, instead try pressing and holding [Ctrl] before Windows starts.)
 - c Select "VGA mode" (or "Low resolution video"), then press [Enter].



Note: If your system stops responding while it's in VGA mode, select "Safe mode" instead.

- 2 To uninstall Matrox software:

Windows 10 – From **Apps & features** in the Windows control panel, uninstall **Matrox PowerDesk** and **Matrox M-Series WDDM Driver**

Windows 8.1 – From **Program and features** in the Windows control panel, uninstall the following:

- **Matrox PowerDesk.**
- **Matrox WDDM Driver, Matrox Driver, or Matrox M-Series Driver.**

Windows 7 – From **Programs and Features** in the Windows control panel, uninstall the following:

- **Matrox PowerDesk**
- **Matrox M-Series WDDM Driver or Matrox M-Series XDDM Driver**

- 3 Restart your computer for the changes to take effect.

- 4 After your computer has restarted, install the latest display driver for your Matrox card. You may also need to reinstall other Matrox software.

Problem Built-in network hardware doesn't work after card is installed

Cause The installation of a card may have caused your computer to reallocate system resources.

Solution Try reinstalling your network drivers.

Solution Try moving your Matrox card to another PCIe slot in your computer. For instructions on how to safely install your Matrox card, see [“Installing your interface card”](#), page 8.

Problem USB keyboard or mouse doesn't work

Cause **Windows 10/8.1/7** – Your keyboard, mouse, or USB Human Interface Device (HID) may not be detected by Windows.

Solution Make sure the USB connectors on your Extio unit are enabled in Windows Device Manager.

- 1 Open the Windows **Device Manager**.
- 2 Double-click **Universal Serial Bus controllers** to expand it. Locate the two controllers named **NEC PCI to USB Host Controller**.
- 3 For both controllers, double-click **NEC PCI to USB Host Controller**, then click **Driver** → **Enable** → **Yes**.
- 4 Double-click **Standard Enhanced PCI to USB Host Controller**.
- 5 Click **Driver** → **Enable** → **Yes**.
- 6 Click **OK**, then close the Device Manager dialog box.

Solution Make sure your device is enabled in Windows Device Manager.

- 1 Open the Windows **Device manager**.
- 2 Depending on your device, double-click **Human Interface Device, Keyboard**, or **Mice and other pointing devices** to expand it, then double-click the name of your device.
- 3 Click **Driver** → **Enable** → **Yes**.
- 4 Click **OK**, then close the Device Manager dialog box.

Problem System doesn't wake from sleep/standby mode

Cause You may be using a sleep mode that doesn't support wake-from-sleep from a remote USB keyboard.

Solution Make sure your system BIOS is set to use *Save to RAM* (or S3) stand-by mode. For more information on setting up your BIOS, see your system manual.

Problem Matrox PowerDesk won't start

Cause Your built-in graphics hardware may still be enabled.

Solution Make sure any graphics hardware is disabled in your system BIOS. For more information on how to access your system BIOS, see your system manual.

Cause The installation of a program using a mirror driver may have modified your Matrox software files.

Solution Reinstall the programs in the proper sequence.

- 1 Uninstall the program using the mirror driver.
- 2 Reinstall your Matrox software.
- 3 Reinstall the program using the mirror driver.

Problem Not all graphics hardware in the computer are fully supported (Software doesn't work with a certain graphics hardware, or another graphics hardware doesn't work at all)

Cause If you have different models of graphics hardware in your computer, your Matrox display driver may not support all the graphics hardware in your computer.

Solution Disable or remove any graphics hardware not supported by the display driver you want to use. If there's graphics hardware built into the motherboard of your computer that's not supported by your software, see your system manual for information on how to disable this graphics hardware.

Cause Windows 10/8.1/7 – If the Windows method for display driver installation was used (instead of running the setup program included with your Matrox display driver), the driver may not be installed for all the graphics hardware it supports.

Solution Run the setup program included with the Matrox display driver. The setup program automatically installs the display driver for each Matrox graphics hardware it supports.

Problem **Screen image defects appear, program doesn't run properly, or Windows doesn't work properly**
(example: mouse pointer not drawn properly)

Cause Some programs may not work properly with some Matrox acceleration.

Solution **Windows 10/8.1/7** – Disable Windows effects:

From the **Settings** tab of the **Performance** dialog box of the Windows **Advanced System settings**, disable one or more features.

Solution If possible, update your Matrox display driver. Matrox makes new display drivers available on the Matrox Technical Support Web site (www.matrox.com/graphics/en/support/drivers).



Note: If you identify a program that doesn't work well with Matrox acceleration, please contact Matrox technical support (see page 41) and describe the problem. This information may help us come up with a fix or work-around in a future driver release.

Problem **Program window or dialog box doesn't appear on screen**

Cause Another window or dialog box may be covering the window or dialog box you want to see.

Solution Move, close, or minimize any window or dialog box that may be covering the window or dialog box you want to see.

Cause If you're using multi-display mode, the program window or dialog box may be in a display or on a monitor that's unusable. (For example, your monitor may not be properly connected or configured.)

Solution Make sure all the displays and monitors you want to use are usable. For more information, see other troubleshooting items in this guide.

Cause The software may be using a display you didn't intend to use or the software may be configured to use more displays than the actual number of monitors you have.

Solution Disable the display:

Windows 10/8.1/7 –

- 1 From the main interface of PowerDesk (see “Accessing PowerDesk”, page 22), click **Multi-Display Setup**.
- 2 In the work area, select the display you want to disable, and then drag it to the **Unused outputs** section. (You can also disable the display by right-clicking it and selecting **Remove**.)
- 3 Click **OK** to apply your changes.

Cause The program window or dialog box may be somewhere off-screen.

Solution If the program window you want to see is named on the Windows taskbar, right-click on it and select **Maximize**. (If you click **Restore** the program window goes back to its previous position. To fix this problem, see the other solutions.)

Solution Manually move the program window or dialog box:

- 1** Make sure the window you want to move is selected, then press [Alt]+[Space].
- 2** If you see a pop-up menu, click **Move**. If you don't see a pop-up menu, press [M] (for **Move**).
- 3** Press on one of the arrow keys once and move your mouse pointer to where you want the window or dialog box to appear, then click. The program window or dialog box should appear where you clicked.

Problem Display on digital monitor appears blurry or uses only a portion of the screen

Cause You may be using a lower display resolution than what your digital monitor supports. If your monitor supports display scaling, the image on your screen may appear blurry. If display scaling isn't supported, the display may use only a portion of your screen.

Solution Select the highest display resolution available. This generally results in better image quality.

Problem Under Windows Server 2008 R2, PowerDesk feature isn't available

Cause By default, Windows Server disables hardware acceleration. Some PowerDesk features require hardware acceleration to be enabled.

Solution Set the hardware acceleration for each display to **Full**.

- 1** Right-click your Windows desktop background, then click **Screen resolution** → **Advanced settings** → **Troubleshoot** → **Change settings**.
- 2** Set the **Hardware acceleration** slider to **Full**.

If you have multiple displays, choose a display before clicking **Advanced** or **Advanced settings**.

Problem Mouse pointer flickers or disappears when it's over a video window

Cause You may be using a customized mouse pointer. Windows draws customized mouse pointers in a way that may cause them to flicker or disappear while they're over a video window.

Solution **Windows 10/8.1/7** – Use default Windows mouse pointers:

- 1 Windows 10 – Open **Mouse & touchpad** from the Windows control panel, and click **Additional mouse options**.
Windows 8.1/7 – Open **Mouse** from the Windows control panel.
- 2 Click the **Pointers** tab.
- 3 In the **Scheme** box, select (or reselect) “**(None)**”, then click **OK**.

Sound

The following troubleshooting items address problems related to sound cards.

Problem No sound, sound doesn't record, or sound output is distorted or too loud

Cause The audio driver for your product may not be installed. For example, the driver installs only if your interface card is directly connected to your computer with a USB cable.

Solution Reinstall your Matrox software.

Windows 10/8.1/7 –

- 1 Windows 10 – From **Apps & features** in the Windows control panel, uninstall **Matrox PowerDesk** and **Matrox M-Series WDDM Driver**

Windows 8.1/7 – From **Program and features** in the Windows control panel, uninstall the following:

- **Matrox PowerDesk**
- **Matrox WDDM Driver, Matrox M-Series WDDM driver, or Matrox M-Series XDDM Driver.**

- 2 From the control panel, click **System and Security*** → **System** → **Device Manager** → **Sound, video and game controller** (double-click*).

(* Depending on your configuration of Windows, this part of the step may not be necessary.)

- 3 Under **Sound, video and game controllers**, right-click your **Extio Sound AAXXXX** (where AAXXXX is the serial number of your Extio unit) and click **Uninstall** → **OK**.
- 4 Restart your computer for the changes to take effect.
- 5 After your computer has restarted, install the latest display driver for your Matrox card. You may also need to reinstall other Matrox software.

Cause If the sound problem is with a particular device (for example, TV or speaker), the volume control on the device itself may need adjusting.

Solution Adjust the volume control on the device itself.

Cause **Windows 10/8.1/7** – Your sound card’s Windows software settings may be incorrect. Specifically, input or output may be disabled, or volume levels may be too low or too high.

Solution Make sure your sound card’s Windows software settings are correct.

Windows 10/8.1/7 –

1 Right-click the speaker icon ( or ) on the Windows taskbar.

If you *don't* see the speaker icon:

a Right-click your windows taskbar, and select **Properties**.

b Under Notification area, click **Customize**.

c Next to Volume, select **Show icon and notifications**.

d Click **OK**.

e Right-click the speaker icon on the taskbar.


2 Select **Playback Devices** and make sure all the devices you want to use are listed as working. If a device is listed as not working, right-click the device icon and select **Enable**.



Note: To see all your devices, right-click anywhere on the property sheet and make sure **Show Disabled Devices** and **Show Disconnected Devices** are enabled.

3 For each device you want to use, double-click the device icon and select **Levels**. Make sure the




volume slider value is okay and the volume button is enabled (). Click **OK**. (To test the volume of a playback device, right-click the device icon in the **Playback** property sheet and select **Test**.)

4 Select **Recording** and make sure all the devices you want to use are listed as working. If a device is listed as not working, right-click the device icon and select **Enable**.



Note: To see all your devices, right-click anywhere on the property sheet and make sure **Show Disabled Devices** and **Show Disconnected Devices** are enabled.

- 5 For each device you want to use, double-click the device icon and select **Levels**. Make sure the volume slider value is okay (if you're not sure, try a value of 50) and the volume button is enabled (). Click **OK**. (To test the volume of a recording device, make sure an audio source plugged into it and playing, then watch the volume meter next to the audio device icon. The volume meter should be between 60 and 100%.)
- 6 To hear an input device, select **Listen** and make sure **Listen to this device** is enabled. Also make sure no other input device has this option enabled. You can only hear one input device at a time. A delay may occur through playback.

Cause Your system may have built-in audio hardware that conflicts with the audio hardware of your Matrox unit.

Solution Disable the built-in audio hardware in your system.

Windows 10/8.1/7 –

- 1 Open the Windows **Device manager**.
- 2 Under **Sound, video and game controllers**, right-click your built-in audio hardware and select **Disable**. For more information on the audio hardware in your system, see your system manual.
- 3 Click **Yes**.

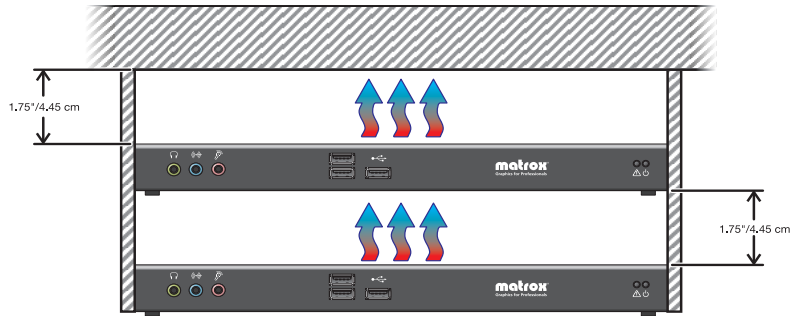

Appendix A – Providing adequate airflow

Because the body of your Extio unit is used to disperse heat, it requires adequate airflow to ensure proper operation and to prevent damage. The following provides guidelines for effective airflow around your Extio unit.

- **Don't block the ventilation holes of your unit** – The ventilation holes around your unit should be unobstructed. Always operate or mount your units rightside up.



To prevent airflow restriction, we recommend allowing *at least* 1.75 inches (4.45 cm) of clearance between the top of your unit and the mounting surface. More space may be required depending on your environment.

- **Operate your unit in a well ventilated location** – Don't operate your unit near a heat source or restrict airflow to your unit (for example, by operating your unit inside a desk cabinet).
- **Monitor your ambient temperatures** – Make sure the ambient temperature doesn't exceed the maximum recommended temperatures.

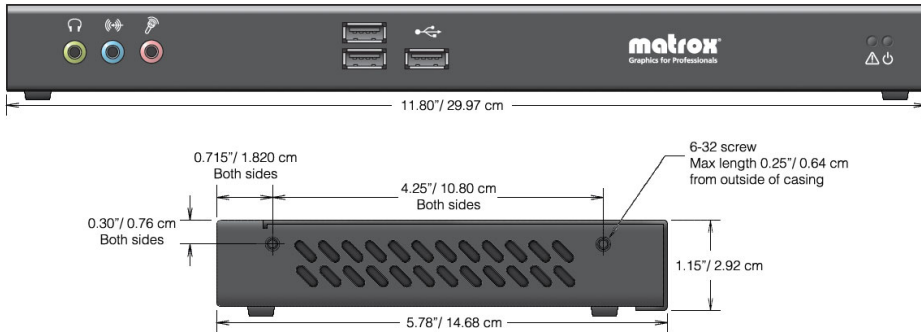

Appendix B – Mounting your units

This section provides guidelines for mounting your Extio unit.

Mounting bracket

Your Extio unit can be mounted in a standard rack or under any hard surface (such as a desk).



- The mounting holes on the unit are 4.25 inches (10.80 cm) apart. Use four 6-32 screws. These screws can enter the casing by a maximum of 0.25 inches (6.35 mm).



WARNING: Using screws that are longer or larger than those specified may damage your Matrox hardware.

- Use a hand screwdriver to carefully tighten each screw. Make sure not to overtighten the screws.
- If installing your unit in a rack, fasten it to the rack as per your rack's instructions.

Mounting guidelines

To prevent damage to your Matrox hardware, read the following guidelines before mounting your Matrox hardware:

- Make sure not to block the ventilation holes on your unit.
- Don't stack anything directly over the unit.
- Make sure all cables and cords are slack.
- Make sure the ambient temperature doesn't exceed the maximum recommended temperatures. For more information, see ["Environmental", page 36](#).
